

****Terms and Conditions of Sale****

1. Identification of the business

These Terms and Conditions of Sale apply to the services offered by:

2. Description of services

Magic Surf School offers surf lessons supervised by qualified instructors.

Lesson duration is as follows:

* 2 hours for group lessons

* 1 hour and 30 minutes for private lessons

The following equipment is included in the service:

* surfboard

* leash

* wetsuit

* rash vest

Transport to the surf spot is also included.

All levels are welcome.

There is no strict minimum age requirement, provided that the child is comfortable enough in the water, is not afraid of the waves, and is able to go under them without hesitation.

The meeting point is at Magic Surf School, ****20 minutes before the start of the lesson****, located at 10 route du Lion, 33680 Lacanau, France.

Lesson times are communicated the day before the session in order to ensure the best possible sea conditions and safety.

3. Registration and payment

All registrations for surf lessons must be made using the registration form.

This form must be duly completed:

* by the parents or legal guardian if the participant is a minor

* by the participant themselves if they are an adult

Payment can be made:

* online

- * in cash
- * by cheque
- * with ANCV holiday vouchers
- * by bank transfer

A deposit of 30% of the total amount is required to confirm the booking.

The balance must be paid no later than the first day of the course or booked service.

4. Conditions of participation

To take part in a service offered by Magic Surf School, each participant must:

- * be physically fit to practice surfing
- * have no known medical contraindication
- * inform the school of any health issue or particular difficulty that may affect the proper running of the lesson

For minors, a duly completed parental authorization form is mandatory.

Outside the supervision times defined by the school, minors remain under the responsibility of their parents or legal representatives.

5. Cancellation, rescheduling and refunds

In the event of exceptional or unfavourable conditions, including dangerous sea conditions, thunderstorms, or any conditions incompatible with safety, Magic Surf School reserves the right to cancel or reschedule a lesson.

In this case, lessons that cannot be provided may, depending on the school's schedule and the client's availability:

- * be rescheduled to a later date
- * be converted into a credit valid at Magic Surf School
- * be refunded as a last resort if no other solution is possible

****Cancellation by the client****

In the event of cancellation:

- * more than one month before the service: the full deposit will be refunded
- * between one month and 15 days before the service: 50% of the deposit will be refunded
- * less than 15 days before the service: the deposit will not be refunded

Lessons not attended due to the participant, in particular in the event of absence, lateness, withdrawal, or failure to show up at the meeting point, are non-refundable.

Any lesson that has started is due in full.

6. Liability

Participants are under the responsibility of Magic Surf School only during the lesson times defined and communicated in advance.

At the end of the scheduled time slot, minor participants once again become the responsibility of their parents or legal guardians.

Magic Surf School's liability ends outside these periods of supervision.

Parents or legal representatives must make sure that the lesson is taking place before leaving their child at the surf school.

Participants' personal belongings remain under their sole responsibility.
Magic Surf School cannot be held liable for the loss, theft, or damage of personal belongings.

Any equipment provided must be used in accordance with the instructions given by the instructors. In the event of intentional damage or damage resulting from clearly inappropriate use, the participant may be held liable.

7. Insurance

Any person booking a service with Magic Surf School is covered by the school's professional public liability insurance strictly within the framework of the activities supervised by the school.

This coverage does not apply to the theft, loss, or damage of personal belongings.

It is the responsibility of each participant to ensure that they have their own personal liability insurance and, if they wish, personal accident and/or repatriation insurance.

8. Right of withdrawal

In the case of a booking made remotely, in particular online, by telephone, or by email, the consumer client benefits from a 14-day right of withdrawal from the date the contract is concluded, unless a legal exception applies or the client expressly requests that the service begin before the end of this period.

Where the client expressly requests that the service begin before the withdrawal period has expired, they acknowledge that performance may begin before the end of that period, in accordance with the applicable regulations.

9. Consumer mediation – Disputes

In the event of a dispute, the client is invited to contact Magic Surf School first in order to seek an amicable solution.

In accordance with the provisions of the Consumer Code, the consumer client may use, free of charge, a competent consumer mediator for any dispute relating to the performance of a service.

The contact details of the relevant consumer mediator will be published on the Magic Surf School website and in these Terms and Conditions as soon as the company has joined the relevant mediation scheme.

10. Applicable law

These Terms and Conditions of Sale are governed by French law.
